During the year, **9** (Nine) meetings of the Board were convened and held **30.04.2019, 28.06.2019, 16.09.2019, 25.09.2019, 08,10,2019, 01,11,2019, 31.12.2019, 03.01.2020 and 31.03.2020**. The time gap between two consecutive meetings of the Board did not exceed one hundred and twenty days.

LOANS GUARANTEE AND INVESTMENT

The Company has given a corporate guarantee of Rs. 50,00,00,000/- (Rupees Fifty Crore Only) to its Subsidiary Company AKS Medical & Research Centre Private Limited as agreed by The Nainital Bank Ltd with some revised conditions of existing loan with the subsidiary.

Another corporate guarantee of Rs. Rs. 29,00,00,000/- (Rupees Twenty Nine Crores Only) to its Subsidiary Company AKS Medical & Research Centre Private Limited as agreed by Punjab National Bank.

Further, Another corporate guarantee of Rs. Rs. 7,50,00,000/- (Rupees Seven Crores Fifty Lacs Only) to its Subsidiary Company AKS Medical & Research Centre Private Limited as agreed by Tata Capital Financial Services Limited.

All above guarantee was within the limit stipulated under section 186. Necessary approvals of central government have been taken in this regard.

Further the Company has made an investment of Rs. 4,99,98,500.00 (Rupees Four Crores Ninety Nine Lacs Ninety eight Thousand Five Hundred only) in the form of Equity share capital in its subsidiary AKS Medical & Research Centre Pvt. Ltd.

Further that the Company has not given any loan nor provided any security in connection with a loan to any person under section 186 of the Companies Act 2013.

There were no contracts or arrangements entered into by the company in accordance with provisions of section 188 of the Companies Act, 2013. The Company had come up with a 375 bedded super specialty hospital at HO-1, Sector-1, Greater Noida West through its subsidiary M/s AKS Medical & Research Centre Pvt. Ltd. The construction was completed and the commercial operations of the project have been started from June 2020 onward.

1 Significant Accounting Policies

1.1 Nature of Operations

Deferred tax assets are recognized and carried forward to the extent that there is a reasonable certainty, except arising from unabsorbed depreciation and carry forward losses where deferred tax assets are recognized to the extent that there is virtual certainty, that sufficient future taxable income will be available against which such deferred tax assets can be realized.

1.6 Earning Per Share

Basic earnings per share are calculated by dividing the net profit or loss for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. For the purpose of calculating diluted earnings per share, the net profit or loss for the year attributable to equity shareholders and the weighted average number of shares outstanding during the year are adjusted for the effects of all dilutive potential equity shares.
